"Besides, destabilization is good for business."

"When a person commits a felony, they are imprisoned and lose the right to vote for having broken the social contract. Simply, he loses his rights as a citizen. He is treated as **NOT** being a citizen.

"The list of the U.S.' crimes is too great to help but make the obvious conclusion: the U.S. is this planet's terrorist and the greatest threat to this planet's peoples in human history.

"...the '**competent**' use of force, the U.S. threat to our planet surpasses the danger posed by either the Romans or the Nazis. If felons are not 'real citizens', in terms of the privileges afforded...beyond human rights, be certain that the U.S. is NOT a 'real country'.

"Regrettably, the felon is in prison, but the *enfant terrible*, the U.S., is heavily armed and on the loose."

"The 23-year history of these documents detailed the several tools being employed in the covert war against the most geopolitically essential and resource-rich country on our planet, Canada.

"This country may die, but this book aims to at least ensure that tomorrow's historical revisionists not be as successful as they have been since 9/11."

"The agreement to yield Canada's sovereign dollar (CAD) for merger with the U.S. currency (USD) is approaching; the relinquishing of the other two pillars of sovereignty, namely, a sovereign border and military, would be a matter of course."

“Very much related, it was Brian Mulroney who caused the bulk of our trade to be transacted with the U.S., moving the expansion of trade away from Asia — **contrary to the strong advice given to Canada by Asian leaders at the Asia/Pacific Rim Conference during his first term.** Mulroney was openly advised to resume the course upon which Prime Minister Pierre Elliot Trudeau had put us.”

“Given the realpolitik, can Canada ever regain control of its once-sovereign currency, rather than surrendering it to the U.S.? Can this country rebuild its once-sovereign economy?”

“THE ANSWER IS NO: The U.S. would engage in a blatant act of currency war to cause the failure of Canada’s dollar. The quickest means include ravaging the Canadian economy or forcing currencies to be gold-backed *since it would all of a sudden suit them.* Notwithstanding the size of the *U.S.’ imaginary debt,* it does hold more gold than any other country, while Canada stands alone in the world in having NONE.”

“Never forget, water is to be thought of as a new currency.

“Compassion for people’s needs is not the same as serving Coca-Cola’s open desire for our most important resource for their financial gain. Coke’s chairman has been open about the corporation’s need to create access to Canada’s difficult-to-obtain water reserves.

“Canadians are not a people who would wish to deny their neighbours a plentiful water supply — but denial of free market pricing is unacceptable. The U.S. has been selling Canadians their own resources since Confederation, and it must stop now if Canada’s sovereignty is to survive.

“Deals made with corrupt politicians are no longer to be rewarded with entitlement. **Rather, the corrupt are entitled to Canadian claims for damages that were and are the result of tampering.** The latter is an act of war and is not to be rewarded.”

*“Pentagon advisor John Burke has claimed that “our enemies will attack us with weapons of mass destruction,” referring to a “financial Pearl Harbour” by using **currency** in the fashion described in this chapter. Clearly, the U.S. technique is to draw attention to those accused of what they themselves do...”*

“Before defaulting on international debt, the conjured money will have initially benefited from its international acquisitions and domestic write-offs.

“Specifically, the U.S. will have acquired foreign property (i.e. – Canada) and written off mortgages, student loans, debts to the IRS, and all manner of corporate and retail bankruptcy issues, as examples of how healthier domestic balance sheets will have been achieved. All of **this “wealth” will have been paid for by the entire world** that has accepted the USD as the international currency.

"A grateful U.S. citizenry will again fully support its government's actions, including the vilification of the Chinese."

“Since Continentalization will supply the U.S.’ citizenry with **all that it requires resource-wise**, ‘The Great Write-off’, as it will perhaps have come to be known, will have represented *the greatest and best-planned heist in the history of the world.*”

“When the CAD suffers its next major crisis, perhaps to new all-time lows, at that point, all citizens who are dependent on government payments...will feel choked into accepting anything to survive; no one will be in any position to fight the collaborators’ surrender of Canada’s once-strongly backed sovereign currency.”

“In a lawful world, the U.S.’ electronic money printing has created a **force majeure**. Still, the U.S. is its own judge, jury, and contract enforcer, such privilege self-bestowed and sanctioned by its military.”

“... - CNN — openly editorialized that the Canadian dollar (which was low at the time) must be kept up to protect U.S. jobs.

“...while the European Central Bank, Japan, China, the Swiss, and, of course, the U.S., have been stepping up their debt monetization programs.”

“...but one must look at who is leaving the sphere of U.S. domination and indeed joining the Chinese establishment of a new **international medium of exchange**. **When war erupts, see if historical currency events have already begun to precede military engagement.**

“Therefore, be warned that the events that will take place relatively soon will appear to be out of the blue and shocking — when the perpetrators have been planning and preparing to pounce on the effects of shock and awe for a very long time. Just as 9/11

ushered in the so-called Patriot Act, **the U.S. will make its next great (and greatest ever) imperialist advances amid the coming contrived panics.**"

"CANADIANS, NOTE WELL: As the head of the European Central Bank, **Mario Draghi** had observed and made comments to the effect that **central banks which sold their gold have, historically, 'regretted it'**. It should not require a major banker to warn of this."

"With de facto colonization having already occurred, what else is needed to suggest to Canadians to pay attention — that **annexation is unfolding now via the currency?**"

"*GoldCore* reported on February 12, **2014**, regarding the effects on banks when housing prices decline:

*"Preparations have been or are being put in place by the international monetary and financial authorities, including the Bank of England, for **bail-ins**. Much of the public is unaware of these developments, the risks and the ramifications."*

"Stephen Harper instituted bail-in measures, dismissing them as inconsequential. Meanwhile, the opposition parties sat and watched. Most Canadians remain unaware of the poisonous seeds that have taken root in the soil of their sovereignty."

"...a deliberate strategy to transfer private U.S. citizens' debts to the public sector, thereby gaining the military's financial strategic protection...Namely, Canadians will have no choice but to accept the merger of the currencies to survive, and with the currency's unification, so too will our sovereignty be squeezed into making, quite literally, a fatal choice."

"...and considering that U.S. **corporate** debt may even be ranked **higher** than its government's **sovereign** debt..."

"To whoever was prepared to hear and interpret it, U.S. investors have been saying...: *"If the world is prepared to keep giving us **goods and services for our paper**, we'll keep printing it, especially if we **can continue to use it to buy up your companies.**"*

"The 'legality' of any contract that affects a nation's sovereign debt obligation (or any contract, for that matter), including the related monetary policy that the sovereign possesses in defence of its interests, may not be ruled upon by the

perpetrator of a *force majeure*. Nor should it assume the right to rule on said contract's validity, since it is the *perpetrator that caused it...*

"...ONLY A THIRD-PARTY MAY RULE ON THE VALIDITY OF ANY ASPECT OF AN AGREEMENT. THIS SHOULD BE OBVIOUS WITH RESPECT TO THE RULE OF LAW GOVERNING INTERNATIONAL AGREEMENTS."

"At a minimum, the United States will guarantee its currency's primary role in the Americas, following continentalization and the successful campaign to actualize Manifest Destiny. For the U.S. dollar to become the dominant medium of exchange throughout the Americas, continentalization would have had to be a more than sufficient first step...

"...Since the writers, analysts and public do not understand that the U.S. rulers have been willfully creating these circumstances, the prevailing view is that the U.S. and its banks are out of control, far from it."

"The U.S. rulers have guided and been in total control of the unfolding global drama since 2001. As with all this century's major events and geopolitical shifts, the *masters of war* have been and are in total control.

"Shocking global events are only shocking for those who do not perceive that there is no loss of U.S. control at all, since calamitous happenings will have again been carefully planned well in advance. *Shocked are only those who do not grasp the interconnectivity of all the essential ingredients for the condition of chaos, from which the perpetrators will have profited in multiple ways, owing to the ensuing permanent changes to our world.*

"In fact, the post-2001 period has been to lay the ground for this next major wave of *imperialist revolution*.

"This book — as with all the documents that preceded it since **2003** - is about finally allowing the public the opportunity to understand the willful plans that explain how Canada's sovereignty will have been consumed by **covert U.S. terrorism.**"

"To put this simply, the U.S. will cancel its debt and militarily protect the wealth of its corporations and ultra-wealthy. In this way, a U.S. government default does not suggest impoverishment, as would be the case with a democracy that is internationally accountable.

"The U.S., therefore, will empty itself of most or all of its debt while keeping its riches on private books. The private sector — corporations and the ultra-wealthy — will reset

completely, as the U.S. satisfies all needs via continentalization. **THIS IS GOING TO HAPPEN!**"

"Think: Why would a country with an AAA bond rating need a bail-in clause?

"During a compressed time, U.S.-style "shock and awe" will have come amid a period of great diversion and upheaval. **The U.S. typically plans and benefits from such a scenario to effect permanent change."**

"Referring to the capacity to effect **bail-ins** to save large banks, on December 11, **2013**, Mr. Tucker of **The Bank of England** was quoted in GoldCore commenting that "**U.S. authorities** could do it today — and I mean today."

"Per a **January 2024 article**, and in his urgent plea to Canadians, **Pierre Poilievre** advanced a petition to **surrender Canada's seat at the United Nations**, along with all ties to its affiliated bodies. This includes the World Health Organization. The wording was unequivocal:

"We, the undersigned, Citizens and Residents of Canada, call upon the House of Commons in Parliament assembled to urgently implement **Canada's expeditious withdrawal from the UN** and all of its subsidiary organizations, including WHO."

"With a Poilievre election victory, such extreme, far-right madness would not merely harm Canada — it would terminate it...It reflects an ideology of anti-internationalism that terminates Canada as a sovereign entity. Canadian neo-conservatism has been radicalized beyond the average citizen's comprehension."

"These are all **freebies for the U.S. public that the world will have paid for once the U.S. cancels its debts**. The U.S. prints paper to expand the military, which supports the invented currency."

"With the election upon us, it merits repetition. **Poilievre** is proud to have served under **Harper**, who mockingly and arrogantly claimed that he wanted to protect hunters' rights..."

"The rights of the comparatively tiny population of hunters supersede those of a population that wants guns to be made illegal (as Canadian surveys have shown)?"

"Poilievre's mentor was openly defiant regarding guns and the gun registry because, truthfully, Harper did not care if everyone knew his thoughts and feelings about

firearms, capital punishment, abortion, French Canadians, Native Canadians, gays, or anything else that reflected his role as a base and inferior U.S. political puppet.”

“To all Canadians: *Remember, once the U.S. enters, they never leave.*”

“Control over communications for propaganda is essential for any fascist state, and the privatization of the *CBC* would be the next logical step,...Poilievre has openly proclaimed that he will finish the job. **U.S. networks will replace Canada’s as part of the communications and propaganda** control upon which **imperialism** and **nationalism** are intrinsically dependent.

“I suspect that the coming major steps may include the replacement of **CTV** with **ABC** and **CBS**, perhaps taking **Global TV’s place (all separate and apart from the CBC’s privatization)**. ...**ROBtv** became **BNN**...If Poilievre wins, it may all come to pass very quickly after a **contrived market collapse makes these assets cheaper to acquire.**”

“Any reform, no matter how sweeping or simplistic, is immediately achievable when framed as a *‘reasonable’* venture — that is, a reform that improves the existing condition while...assuming a willingness to refine further, if, as and when needed.

“The simple logic employed above has been stifled by fear, political cowardice, and by those who would delay reforms in the service of foreign interests, or by old-fashioned ideological stagnation (*electoral reform, etc.*).”

“Cancel the accord permitting U.S. military access to Canadian soil. Harper’s signing of that agreement was an act of high treason.”

“INTERNATIONAL: United Nations membership must be mandatorily linked to recognition of BOTH the **civil** and **criminal courts** at The Hague. Any international or extranational agreements and contractual disputes must be adjudicated at The Hague. NO PARTY TO AN ACCORD OF **ANY** KIND MAY NOT HAVE THEIR OWN NATION’S COURTS ADJUDICATE A CONTRACT OR AGREEMENT. INCLUSION OF THE CRIMINAL COURTS ASSURES THAT **U.S WAR CRIMINALS** WOULD BE JUDGED, AS WITH ANYONE ELSE.”

“Absent legislation, corporations will continue to fill food with addictive additives... ignoring the path of disease prevention that politicians could legislate. Imagine lacing cookies with substances that cause children to want more, leading to obesity, for Big Pharma to respond to with its sundry concoctions.

"It is not the U.S. corporations that serve our health; only the People can do so...would serve our health interests above profits. Canadians need not allow the U.S. chemical and pharmaceutical industries to make us ill with their cancerous food or medications."

*"Without the possibility of a **minority government**, they are unwittingly supporting the violent animal that is the U.S. political infrastructure. Only the campaign to create a political system that allows for a minority government would finally break the anger caused by frustration, thereby delivering a peaceable and critical **blow to violence**."*
